1. Tenders should be in prescribed form available at the Office of V.C & Managing Director, A.P.Co-op Oilseeds Growers Federation Ltd, Do : 55/17, 2 to 4, 4 th Floor, C Block, Near CGO Complex, Auto nagar, Vijayawada-520010 on payment as specified above on any working day ie., Monday to Friday during office hours on the dates mentioned above.
2. Application should be accompanied by,
  - a) Copies of attested registration certificate as per G.O Ms no 94 dated 01-07-2003.
  - b) Attested experience certificate from the concerned authorities as detailed in condition no.(3) below.
  - c) Crossed D.D 's towards cost of tender schedules including VAT as specified in tender notice and EMD as specified separately in favour of **A.P.Co-op Oilseeds Growers Federation Ltd,payable at Vijayawada.**
  - d) Attested Copy of valid VAT registration with commercial tax department.
  - e) Attested Copy of PAN
  - f) The application without enclosing above certificates (a) to (e) will be summarily rejected.
  - g) All principal construction materials like cement , Steel, Gravel etc., shall be procured by the contractor, the federation will not issue any materials required for the work.
- 3) The tender schedules will be issued to such contractors who ever satisfies the eligibility criteria and who are preferably having experience in Site filling works/Site levelling works of similar magnitude. The eligible contractors submit experience certificates from the concerned authorities from Government, Government undertakings.
- 4) The V.C & Managing Director, A.P.Co-op Oilseeds Growers Federation Ltd, reserves the right to reject the issue of tender schedules for such of applicants whose performance is not satisfactory and those were penalized repeatedly for enormous delay / bad workmanship.
- 5) The V.C & Managing Director reserves the right to alter or postpone the dates mentioned in the above tender notice and reserves the right to reject any or all the tenders without assigning any reason thereof.
- 6) The cost of tender schedule once remitted is not refundable under any circumstances.
- 7) The tender schedules are not transferable.
- 8) The contractors may submit their tenders during working hours on any working day from the date of issue of tender schedules to last date and time for receipt of tenders indicated in above notice.. Tenders may be submitted by the contractors either in person or through an authorized agent.

- 9) If due to any reason the office happens to remain closed on the last date of receipt of tenders as specified in the tender notice , the tenders will be received on the next working day at the same time and venue and the tenders will be opened on the same day and time.
- 10) The tenderers who withdraws his offer within the validity period of three months mentioned in the schedules will forego his EMD.
- 11) The tenderer who purchases the tender schedule should submit the tender without fail. If for any reason, he fails to submit the tender after purchase , his EMD paid along with the application will be forfeited. No representation of the tenderer will be considered in this regard.
- 12) The tenderer will not be required to quote item wise rates . He should indicate his willingness to do the work either at the estimated value of the work or at a percentage less than the estimated value or at a percentage in excess than the estimated value in columns provided at the end of schedule 'A'.
- 13) The successful tenderer should pay the balance **EMD @ 1½%** on value of work through a **crossed demand draft** obtained in favour of **A.P.Co-op Oilseeds Growers Federation Ltd, payable at Vijayawada.**
- 14) The EMD will be refunded to all the unsuccessful tenderers after deciding the tenders or after expiry of 3(three) months time from the date of opening of tenders whichever is earlier.
- 15) Seigniorage charges, V.A.T , Income tax etc., will be deducted from the bills of contractor at the applicable rates and remitted to the concerned departments by the federation. No request of the contractor for non-deduction of taxes will be considered.
- 16) The Agreement concluded for the work will be cancelled and the deposit amount paid by the contractor will be **forfeited** in case the certificates ( Registration, experience, Income tax, V.A.T, etc.,) produced by the contractor along with the application requesting for supply of tender schedule are found to be **false** at a later date. The contractor will be placed in blacklist and payment for the work already done by him up to that date will not be made.
- 17) In case of ambiguity in regard to conditions and qualification criteria and other related matters if any with the Tenders the decision taken by the V.C & M.D, A.P.CO-OP Oil Seeds Growers Federation Ltd, Vijayawada-520010 shall be final and binding on all Tenderers.
- 18) Identity card of the contractor issued at the time of registration should invariably be produced by the contractor of eligible class if demanded for issue of Tender schedule at the time of submission of tenders, and at the time of concluding the agreement.
